# **Monmouth Preparatory School**

### **About Monmouth Preparatory School**

Monmouth Preparatory School is an independent boarding school for boys and girls from the age of 2 1/2 to 11years. The preparatory school is part of the Haberdashers' Monmouth family of schools that includes Monmouth School for Boys and Monmouth School for Girls.

The school is split across two sites, 'Agincourt' where pupils from Nursery to Year 2 are taught and 'The Grange', which accommodates pupils in Year 3 to Year 6.

The school has 257 pupils on roll. A majority of pupils come from Wales, a minority from England and a very few from overseas. All pupils are from English speaking families. A few pupils are bi-lingual or multi-lingual with languages spoken at home including Welsh, Cantonese, Mandarin, Greek and Italian.

There are 40 pupils identified as having additional learning needs and receiving additional support, none have a statement of special educational needs.

The headteacher of the preparatory school oversees the day-to-day running of the school. In addition, there is an overarching principal and governing body for the Haberdasher's Monmouth group of schools.

Inspectors visited the school on 1 and 2 February 2022, an additional inspector also carried out an inspection of the premises on 2 February. During the visits, we gathered evidence from the following sources:

- discussions with the Principal and the headteacher of the preparatory school
- scrutiny of relevant documents, including policies, curriculum plans, staff appointment checks and premises and installation test certificates
- learning walks
- meeting pupils with their work
- inspection of the school premises

### Main findings

### **Strengths**

- The school site provides a rich environment for learning. Nearly all pupils have access to high quality facilities, which supports their skill development well.
- Many pupils in Agincourt make appropriate progress in their skill development. In the Grange most pupils exhibit strong recall and high standards.
- Most pupils across the school have positive attitudes towards their learning. They are excited to learn and proud of what they achieve.
- Many pupils are developing their self-esteem and show independence, confidence and the ability to problem solve and make informed decisions. They have a strong awareness of other cultures and traditions.
- Many teachers deliver well-planned lessons, both within and outside the classroom, using stimulating resources. In Agincourt there is a suitable balance between teacher and pupil led activities. Many teachers across the school provide regular feedback to pupils that moves their learning on.
- Most staff across the school promote pupil's personal and social development effectively.
- Leaders are developing clear roles ands responsibilities. They are experienced in running independent schools and have established a strong culture of learning.

#### Recommended areas for action

- Leaders should ensure that all policies accurately reflect the practice in the preparatory school.
- Ensure that all teaching consistently challenges or supports pupils well enough to develop their skills and understanding further.
